Circular Letter No. 00-1343

RE: NCCI ITEM B-1362 - Code 5551 - Roofing - Amended Phraseology

The Minnesota Department of Commerce has approved the above filing to become effective 12:01 a.m., July 1, 2000, applicable to new and renewal business only. The purpose of this filing is to eliminate National Council's requirement that yard employees of roofing contractors be classified under Code 5551— Roofing - All Kinds & Yard Employees, Drivers.

Periodically National Council reviews individual classification codes and classification groups by industry to determine if certain classifications should be considered for elimination, phraseology modernization, or phraseology clarification. Based upon one of these reviews, NCCI is recommending the elimination of yard employees from the roofing contractor classification. In reviewing this item, it should be noted that Minnesota already allows for separate classifying of the yard employees of roofing contractors for premium purposes in accordance with M.S. 79.211.

The attached exhibit illustrates the changes necessary to the *Basic Manual* to implement the elimination of yard employees from the roofing classification, Code 5551. Since separately classifying yard employees for premium purposes is already possible in our state, Assocation staff anticipate no significant impact on current premium levels in Minnesota as a result of this filing. National Council does, however, anticipate that employers in the roofing industry in other states may experience a decrease in premium due to the reassigning of qualifying employees to the yard classification, Code 8227. It should be noted that the proposed language on the attached exhibit page contains underlined as well as strikethrough text. The underlining represents new or added text while the strikethroughs indicate deleted text.
