RE: MWCIA Website Enhancements

The staff of the Minnesota Workers' Compensation Insurers Assocation are pleased to announce the release of the following enhancements to MWCIA's website:

Online Ratesheet Ordering System

The *Employer Experience Modification Search* feature now allows authorized users the ability to order Minnesota experience modification ratesheets on-line. In connection with the implementation of this new feature, Minnesota employer modification histories are now included as part of MWCIA's annual subscriber fee. The price of an individual experience ratesheet when ordered on-line is \$5.00. All ratesheets ordered by mail or via our fax service will now cost \$10.00 per ratesheet to offset the added expense of manual processing.

■ Minnesota Classification Index (MCI)

The Class Code Search and Assigned Risk Rate Search programs are now available free of charge as an on-line service to MWCIA's members, subscribers and the general public. These programs allow users to determine standard job classification codes by entering simple job descriptions and to determine current Assigned Risk Plan rates by entering their corresponding 4-digit classification codes.

In addition to the above features, the following enhancements have recently been implemented on MWCIA's website:

Carrier Rate Search (public access)
Assigned Risk Depopulation Reports
more 'help' box information
