Circular Letter No. 01-1360

RE: Premium Due Date Endorsement

The Minnesota Department of Commerce has approved the above filing effective 12:01 A.M., February 20, 2001, applicable to new and renewal business only.

Standard Workers' Compensation & Employers Liability Policies (WC 00 00 00 A) currently do not address the due date of audit premiums or retrospective premiums. Due dates are key in determining whether or not premium balances are admitted. When due dates for receivables relating to a policy are not addressed by policy or contract provisions, however, the proposed endorsement language requires treating any uncollected audit premium, whether accrued or billed, as non-admittable. Beginning with the 2001 policy year, the National Association of Insurance Commissioners' (NAIC) Statement of Statutory Accounting Principles No. 6 establishes statutory accounting principles for direct and group billed uncollected premiums and bill receivable premiums as well as amounts due from agents and brokers. These items are admitted assets to the extent that they conform to the requirements of this statement. The language of the proposed endorsement establishes the due date for audit premiums and retrospective premiums as governed by policy or contract provisions.

The attached exhibit illustrates the changes necessary to the Forms Manual to implement the creation of a Premium Due Date Endorsement (WC 00 04 19). The language that is being added by this endorsement to *Part Five.D – Premium Payments* has been underlined. Additionally, the listing of applicable endorsements appearing in the Minnesota Exception pages of the *Basic Manual* will also be corrected to reflect the addition of WC 00 04 19.

PART FIVE PREMIUM

D. **Premium** is amended to read:

You will pay all premium when due. You will pay the premium even if part or all of a workers compensation law is not valid. <u>The due date for audit and retrospective premiums is the date of the billing.</u>
