Circular Letter No. 04-1413

RE: Statistical Codes 9721, 9722, 9723, 9724

The Minnesota Department of Commerce has approved the above filing to become effective February 1, 2004.

The purpose of this filing is to establish four additional codes to report statistical data for independent carrier credit or debit programs where specific codes do not already exist in the *Minnesota Statistical Plan Manual*. The approval of this filing will also help facilitate consistent coding by Minnesota carriers who write multi-state accounts. Please note, however, that the approval of Statistical Codes 9721-9724 is not intended to replace codes already approved for independent carrier scheduled credit plans, rate deviations, large deductible programs, or any other programs where specific reporting codes have already been approved for use in Minnesota. It should also be noted that the use of independent carrier codes that have not been filed by MWCIA and approved by the Department of Commerce may not be used in Minnesota. Carriers must continue to use the methods established by the Commerce Department for filing special credit/debit programs in Minnesota and should contact MWCIA prior to using Statistical Codes 9721, 9722, 9723, or 9724 to confirm that a different statistical code does not already exist in Minnesota for reporting their carrier specific credit or debit program.

The attached Exhibits I - IV illustrate the changes to the *Minnesota Statistical Plan Manual*, the *Basic Manual*, and the *Classification Codes & Statistical Codes Manual* necessary to affect this filing item. In most cases, the new language has either been underlined or highlighted for your convenience.

A NOTICE TO MEMBERSHIP:

The Minnesota Department of Commerce requests that MWCIA remind its members that the above filing only applies automatically to insurance companies who have filed a Limited Power of Attorney agreement with our Commerce Department. A properly executed Limited Power of Attorney authorizes MWCIA to make filings on behalf of individual insurance companies. Any insurance company who has not filed a Limited Power of Attorney must independently submit the changes represented in each filing item to the Minnesota Department of Commerce for their approval.
