MINUTES OF THE 1999 ANNUAL MEETING OF MEMBERS

The Annual Meeting of the Minnesota Workers' Compensation Insurers Association, Inc. (MWCIA) was called to order by President Bruce Tollefson at 10:00 a.m., Tuesday, April 20, 1999, at the Decathlon Club, 1700 East 79th Street, Bloomington, Minnesota.

President Tollefson welcomed the representatives of members in attendance and proceeded with the taking of the roll call. Vice President Linda Hanson presented the Notice of Annual Meeting dated March 16, 1999, as proof of proper notification of the meeting. By unanimous consent a reading of the Notice was waived. Ms. Hanson then presented an affidavit regarding the mailing of the Notice of Annual Meeting and Proxy materials to each of the members of MWCIA.

Ms. Hanson was then called upon to report as to the presence of a quorum. Ms. Hanson reported that nineteen (19) members had registered and seventy-four (74) members were represented by Proxy on file at MWCIA. This represented more than 25 percent of all members entitled to vote and the presence of a quorum for the transaction of business was declared.
