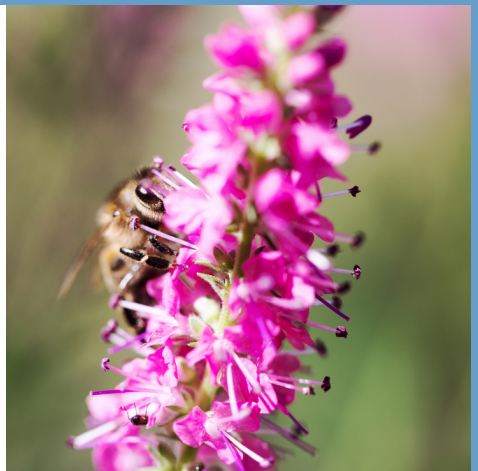

FEDERAL EMPLOYMENT ID NUMBERS AND UNEMPLOYMENT ID NUMBERS WHY ARE THEY REQUIRED?

Workers' Compensation is law driven, as such there are many pieces to workers' compensation that happen and we don't always know or understand why they happen.

One of these questions is why MWCIA collects Federal Employment ID Numbers (FEIN or EIN) and Unemployment ID Numbers (UIN).

We do this to comply with MN Rules Part 5222.2001 Subp 2. N. which specifies that "Every employer's federal employer identification number (FEIN) and unemployment account number" must be present on the declarations page. It counts toward proof of coverage.

These numbers should be obtained from the policyholder when they apply for workers' compensation insurance. In cases where the employer does not have a UI Code or FEIN Number at the time of policy issuance, policies may be issued without these numbers and endorsed once the information is obtained.

The Minnesota Department of Labor and Industry (MN DLI) has contracted with our office to provide them with proof of coverage information through our data collection system.
